## ORDER

Rajosthan Sanskrit Shikshak Prashikshan Vidyalaya, Shahpura Bayh, Amer Road, Jaipur submitted an application to the Northern Regional Committee of National Council for Teacher Education. for grant of recognition of STC Sanskrit Course of two year duration in terms of section 15(1) of NATE Act, 1993.

- 2. WITEREAS the case of the institution was considered by the NRC in its 79th meeting wherein the Northern Regional Committee noted that even after three inspections, the institution has not complied with the norms of NCTE, and the indefinite practice of inspection cannot continue. Therefore NRC refused to grant recognition to the institution U/S 15(3)(b) of NCTE Act. 1993
- 3. AND WHEREAS the Appellate Authority of NCTE vide Order No. 89-234/2004-Appeal id. 29.04.2005 remanded back the case to NRC, Jaipur quashing the Order of NRC, Jaipur dt. 14.07.2004 and directed that the case of Rajasthan Shikshak Prashikshan Vidyapeeth, Shahpura Bagh, Amer Road, Jaipur be processed further.
- 4. AND, therefore consequent upon the Order of Appellate Authority of NCTE and In exercise of the powers vested under Section 15(3)(a) of the NCTE Act, 1993, the Regional Committee granted recognition to Rojosthan Sanskrit Shikshak Prashikshan Vidyalaya, Shahpura Bagh, Amer Road, Jaipur to STC Sanskrit Course of two year duration for one unit (50 seats only), with an annual intake of 50 in the 1<sup>st</sup> year and the same for the 2<sup>nd</sup> year w.e.f. 13<sup>th</sup> June, 2005 vide order dt. 14.06.2006.
- 5. AND WHEREAS the Appellate Authority of NCTE vide Order No. 89-111/2005-Appeal dt. 28.09.2005 remanded the case back to NRC, Jaipur for reconsideration and grant of recognition for 120 seats as per rules / regulations in vague at the time of submission of appliantion.
- 6. Now, therefore consequent upon the Order of Appellate Authority of NCTE and In-exercise of the powers vested under Section 15(3)(a) of the NCTE Act, 1993, the Regional Committee hereby grants recognition to Rajasthan Sanskrit Shikshak Prashikshan Vidyalaya, Shahpura Bagh, Amer Road, Jaipur to STC Sanskrit Course of two year duration for 120 seats (One Hundred Twenty Seats Only), with an annual intake of 120 in the 1" year and the same for the 2<sup>nd</sup> year w.e.f. 30<sup>th</sup> August, 2006 subject to compliance of the following conditions before commencement of the academic session.

- Appointment of the faculty members duly qualified and staff as per the norms of NCTE/ State Govt./UGC is to be completed before the commencement of the
- The countersigned statement of all faculty members from the Director, SCERT. should be submitted before the commencement of the academic session.
- The institution shall adhere to all the other regulations and guidelines as framed C.
- The institution shall within one month of the receipt of Recognition order, convert by NCTE from time to time. the Endowment Fund account into a Joint Account in the form of FDR for a period of not less than 60 months (Five years) in a Nationalized Bank only to be operated . (1 along with an official of the Regional Committee.
  - That the Peserve Fund for an amount equal to three months salary of the Trachers & Stoff be created within one month from the date of issue of this order and maintained in the form of FDR in favour of the management/institution, 2. for a period of not less than sixty months (Five years) in a Nationalized Bark.
  - Before starting the course the institution should seek prior permission of the competent authority for conducting the exams and approval of the curriculum 1. that they are going to adopt for the course.
  - Institutions if starts the training programme without prior approval / permission of competent authority / examining body regarding the curriculum they have adopted and conduct of examination for award of Diploma / Certificate the recognition of such institutions shall withdrawn.
  - Non-compliance of the above mentioned conditions shall cause action under section 17 (1) of NCTE Act, 1993.
- Further, the recognition is subject to fulfillment of all such other requirements as may be prescribed by other regulatory bodies like UGC and State Government, etc.
- The institution shall submit to the Regional Committee a Self-Appraisal Report at the end of each academic year along with a copy of the approval of the affiliating University / State Directorate of Education about the appointment of faculty members and the Statement of Annual Accounts duly audited by a Chartered Accountant.
  - If the institution contravenes any of the above conditions or any of the provisions of the NCTE Ac', Rules, Regulations and/or order made or issued there under, the Regional Committee may withdraw the recognition under the provisions of Section 17(1) of the NCTE Act, 1993.
